Planning Control Matters - Cllr: Bleakman

305. 0631/14 Rushford Mill Farm, The Old Piggery, Chagford

Excavation of land and installation of farm production facilities and ramp and toilet structure (part retrospective). **Resolved:** To Support the principle of the proposed development subject to conditions; the storage facilities should be used only for the storage of cheese and meat products associated with the farming enterprise; the facilities shall not be used for any 'direct to the public' sales activity.

306. 0631/14 7 Rivervale Close, Chagford

Single storey side extension. **Resolved:** No Objection.

307. 0514/14 Chagford House, Chagford

Internal alterations subject to the following condition: the works shall be begun before the expiration of three years. **Noted.**

309. 0540/14 & 0541/14 Chagford House Stables, Chagford

Conversion of first floor space to accommodate office facility, modifications to ground floor to provide access stairs to first floor rooms and installation toilets, plus maintenance and repair to existing brick chimney stacks. **Noted.**

310. Approval of Prior Notification

0585/14 Rushford Mill Farm, The Old Piggery, Chagford

Access track (100m x 3m). Noted.

Site Meeting

311. 0489/14 Waye Hill House, Chagford

Erection of a two storey extension, front extension to entrance hall and glazed canopy over front door. Cllrs: Bleakman and Shears attended a site meeting at the property with the Members of DNPA. Cllr: Bleakman gave a briefing as to why the Council supported the application. **Noted.**
